Phone Conversation And The Directions Given By LORNA HARGRAVES, 798-2111,

LORNA HARGRAVES SAID "THE APPEAL THAT WAS FILED ON, Apr. 02, 2008, WAS NOT ENOUGH, IF THE JUDGE DECIDES TO SEND US TO JAIL WE WILL BE SENT TO JAIL IMMEDIATELY, THEN WE WOULD HAVE TO FILE FOR APPEAL BAIL, AND WE WOULD NOT BE ABLE TO DO THAT FROM JAIL, SO WE WOULD NEED A LAWYER TO FILE FOR APPEAL BAIL".

LORNA HARGRAVES WAS TOLD THAT ONE OF THE ACQUIRED HAD "A COURT APPOINTED LAWYER" AND THE OTHER TWO ACQUIRED HAD "LEGAL-AID-LAWYERS", THE "LEGAL-AID-LAWYERS" SAID THEY WERE ONLY GOING AS FAR AS SENTENCING, THEY WEREN'T GOING ANY FURTHER, THE "LEGAL-AID-LAWYERS" SAID, "LEGAL-AID WOULD NOT PAY FOR THE APPEAL".

LORNA HARGRAVES WAS TOLD THAT IT WOULD BE A "MISARRIAGE OF JUSTICE," IF WE WERE SENT TO JAIL, AND WOULD PUT "THE ADMINISTRATION OF JUSTICE INTO DISREPUTE".

SHE WAS ASKED, IF THERE WAS SOMETHING WE COULD DO BEFORE THIS HAPPENS, SHE SAID "YOU WOULD HAVE TO APPLY BY FAX, TO THE ATTORNEY GENERAL AND THEN SEND THE COPY TO THE APPEAL COURT TO SEE IF THEY WOULD APPOINT A LAWYER FOR THE APPEAL BAIL AND THE APPEAL".

Therefore, In Response To The Direction Given, We Are Applying To "THE ATTORNEY GENERAL" And "THE FEDERAL COURT OF APPEAL", FOR A "COURT APPOINTED LAWYER" FOR "THE APPEAL BAIL", IF THE JUDGE DECIDES TO SEND US TO JAIL, AND FOR "THE APPEAL", TO ADDRESS THE DEFILEMENT OF RIGHTS GUARANTEED BY "THE CHARTER OF RIGHTS AND FREEDOMS", THE DEFILEMENT OF "THE OATHS OF OFFICE", AND "THE DEFILEMENT OF THE CROWN EMPLOYEES FIDUCIARY DUTY TO PREVENT CRIME".




